Open class is held at same time as 4-H classes, although the ribbons are different. **AGILITY RULES:** For the safety of both dog and handler the following agility rules will apply: (1) 4-H members who do not have 1 year of obedience or rally *with this dog cannot* compete in 4-H agility; (2) Dogs less than one year old by June 1<sup>st</sup> of the current year are not allowed to compete in agility; and (3) **Any member wanting to compete in agility MUST attend a minimum of three practice sessions** to familiarize themselves and their dog with the agility equipment.
